_____ **Point in Time/Street Count Committee** – Implements the accurate count of unsheltered homeless persons in accordance with HUD guidance and regulations.

_____ **Data & Performance Measurement** – Ensures local compliance with HUD Homelessness Management Information System (HMIS) data standards, assists to improve agency and community-wide data quality, uses HMIS data and CES data to inform and measure progress.

_____ **Coordinated Entry Oversight** - Monitors the implementation and effectiveness of the CoC's Coordinated Entry System. Reviews and updates relevant CES policies and procedures, marketing materials, and information to make improvements to the system.

_____ **Service & Program Coordination** – Shares, evaluates, expands or obtains information, services, and resources pertaining to the prevention of homelessness to assure efficient and effective disbursement of homeless prevention resources.

_____ **System Performance Measurement** – Utilizes data from Data Performance Measurement Committee to set performance standards and benchmarks for CoC funded projects; reviews and measures System Performance Measurement (SPM) Progress.

_____ **Rank & Review Committee** – Develops tools to review and rank applications for funding; develops a process for approving the submission of applications for persons to achieve stable housing.
