The 2025 HUD Continuum of Care Notice of Funding Opportunity (NOFO) was announced on November 13, 2025. For your information, attached is a summary of the key points in the 2025 NOFO memo for the Continuum of Care NOFO application process. The attached 2025 NOFO Notice also contains detailed information on changes in the 2025 NOFO and links to HUD NOFO informational materials. There are significant changes in the 2025 NOFO. **Please read the notice carefully.**

There are funds available for new projects through CoC reallocation, CoC Bonus, DV Bonus and DV reallocation funds. The CoC bonus amount available is \$1,637,711. The amount available for Domestic Violence bonus projects is \$556,658.

Important deadlines are listed below:

November 18, 2025 – DuPage CoC opens its local competition and posts deadline dates. **Project renewal and new project templates will be sent as soon as HUD posts the application guides.**

December 8, 2025 – New and Renewal projects will submit a CoC project template for evaluation.

December 10, 2025 – Leadership committee ranks all new and renewal projects.

December 13, 2025 – The DuPage CoC Local Competition is complete. Each project application must be submitted in e-snaps for final CoC review.

December 30, 2025 – Each project applicant is notified in writing if their project is accepted, rejected, reallocated or reduced on the CoC Project Priority Listing and it is posted.

Project submission instructions for esnaps will be reviewed at a virtual **APPLICATION WORKSHOP scheduled for December 1, 2025 from 1:30 pm – 2:30 pm.** This is a Zoom meeting. **Advance registration is required.** The registration link is below:
